Automatic Collection of Information

We do not use cookies on the Website. We do not automatically log personal data nor do we link information automatically logged by other means with personal data about specific individuals. We do automatically log user's IP address and session information such as the duration of the visit and the type of browser used. This is recognised by the web server and is only used for system administration and to provide statistics which we use to evaluate use of the site.

Data Collection and Purpose Specification

We collect the personal data that you may volunteer while using our services. We do not collect information about our visitors from other sources, such as public records or bodies, or private organisations. We do not collect or use personal data for any purpose other than the specific services offered.

Children's Privacy

We take specific steps to protect the privacy of children by making reasonable efforts to ensure that
